AND WHEREAS the trustees agreed to become the trustees of these presents as is testified by their being parties to and executing these presents.

The Trust so formed will be known as **Birnagar Educational & Charitable Social Trust** having Head Office at Vill.- Birnagar, P.O.- Birnagar, P.S.- Taherpur, Dist.- Nadia Pin.- 741127, West Bengal and Branch Office at Vill.- Nazirpur, P.O.- Birnagar, P.S.- Taherpur, Dist.- Nadia , Pin.- 741127, West Bengal. The office address may be changed with discretion of the majorities of the Trustees. The area of activity of the Trust will be whole of India.

In pursuance of the said desires and for carrying out such desires into effect, the SETTLOR does hereby grant, transfer and assign upto the TRUSTEES the said Trust fund to have and to hold the said Trust fund upon Trust and subject to the powers provisions and agreements hereinafter declare and expressed concerning the same.

The TRUSTEES shall hold and be possessed of the said Trust fund upon Trust to receive the interest, dividends, rent, gains and other income thereof and there abouts and in the first place to reimburse them or pay and discharge all costs, charges and expenses of incidental and necessary for the management or administration or execution of the Trust and also outgoing rates assessment dues, duties, levies, imports and other taxes payable in respect thereof and the cost of the meeting repairs etc. to any immovable property, if for the time being forming part of the Trust fund and to

apply the residue of the said interest, dividends, gains and other income (hereinafter called the said income) as well as at their discretion, the whole or any part or parts of the corpus of the Trust fund for such public charitable purposes in India namely relief to the poor, health development, prevention of human resources, education and any other object of general public utility not involving the carrying on any activities for profit as the Trustees may think fit and proper.

The accounting year of the Trust will in start from April and will end on 31st March of each year. The Trust account will be audited by duly qualified auditor if its total receipt exceed Rs. 50,000/- (Fifty Thousand). At present and accordingly amendment as and when. The Trust fund will be invested as per provision U/S II (5) of I.T. Act, 1961 as and when amended if the corresponding law permits.

NON DISTRIBUTION OF PROFIT

Any surplus generated from the Trust after making all expenditures shall not to be allowed for distribution as profit among the Trustees and the said surplus can only be utilized for such public charitable purposes.

OBJECTIVE OF THE TRUST BODY

- I) To provide and brought into the society implemertation of financial helo and financial devel opment of the Citizens at large.
- II) To provides services to the society to increase the financial status of the citizens at large.
- III) To provide / impart education to the common people of India and thereby to redicate the employment and proverty of the citizens at large.

- a) By forming educational institutions, school and college to provide Commercial Education, Technical Education Management Education, Mechanical Education, Administration Education, performing Arts. - b) To construct Educational and social buildings and to acquire land for such buildings in the name of the Trust.
- c) To get the Educational Institutions registered with the registering authorities throughout the Indian territory in compliance of law and Rules of the Govt. and semi Govt. Educational authorities.
- d) To appoint Teachers, Professors, Technicians, and all other required personnels for the running of the Educational Institution.
- e) To cause the sanction of various funds from various financial Aid authorities of the Govt. and the Non Govt. authorities.
- f) To keep and maintain disciplined and power and provision for mechanical powers for the Educational Institutional as may be required from time to time.
- g) To obtain money and moneys worth from the donor or individuals and to collect all donations from the citizen of India as well as the non-citizen or various commercial authorities of India and abroad.
- h) To obtain affiliations of the courses and degrees of the said Educational Institution from India Universities or Boards or Associations or in any name they are known.

AND

That the member of the Trust body will not be less than 10 (ten) and more than 13 (thirteen) and existing will be entitled to admit any new Trustee members subject to unanimous decision.

That any member of the Trust body except the President and Secretary may be removed by impeach the rest of the members of the Trustees by majority decision. The President and Secretary may voting in case of impeachment proceedings but will continue to act as President and secretary as the case may be.

That the members of the Trustees while meeting and taking decision and to bring any act jointly will be trated as "Trustee Board". All meerting of the Trustee Board will be presided over by the President and in his absence by the Vice President.

That all the members of trustees will be treated as the first member of the Trust and the office of The Trustees shall if so fact become vacant on the happening of the following

- b. Insolvency
- c. Designation subject to acceptance by the Trustee Board
- d. On being rendered incapable to perform the duties due to old age or continuous of the Trustees illness
- f. On failure to attend four consecutive meetings of the Board of Trustee without sufficient cause or without previous intimation
- g. On being adjudicated as an insolvent by the compitant court.
- h. On being removed or impeached by the majority members of board of Trustee.

The vacancy of any Trustee members will be filled by nomination of either the President or the Secretary subject to approval by the existing members unanimously during the vacancy in the said way, The President or Secretary will have the Power to take decision in case of tie of the meeting of the Board of Trustee however no posts of any member will remain vacant for more than three months.

That not with standing anything stated herein before or hereinafter the President, Secretary, Vice -President Shall in case of any emergency the authorised to take any decision for emergency affairs and all fulfilling emergency needs. The said decision will however be placed and approved before the Trustee Board in its next meeting.

That the Trustee Board shall meet atleast 2 (Two) times a year at a gap of six month in ordinary course. In any occasion, emergency Trustee Board may be called for by the President or the Secretary at any time subject to three days notice to each member indicating the business to be transacted or Discussed .

- (vi) To demand, realize and receive all interest, dividends, rent and investment from person, farms or companies and public debt officers liable to pay the same.
- (vii) To deposit the income of the Trust fund with the Bankers of the Trust appointed by the Trustees who may be any Bank or any Firm, Company or Individual on such terms as the Trustees may decided and also can take Loan from Bank / Financial Institution.

- (xi) To appoint all times of employees for Managing and carrying out the affairs of the Trust or for collection of income thereof and pay and fix such salaries or remuneration as the Trustees may deem fit .
- (xii) To nominate, constitute and appoint attorney or agent and delegate to such attorney or agent all or any of the powers vested in then under their presents.
- (xiii) To accept donations, contribution, either in cash or kind for the object and purposes of Trust from any persons if the Trustees so approved and on such terms and subject to such conditions as may be agreed to.
- (xiv) The board of Trustees will have the power to amend incorporate any additional provisions in future with the condent of 2/3 majority in a meeting of the board of Trustees except the objectives.

7A(ii) In case of non-functioning of the Trust the assets and funds of the Trust if any, after, meeting up its debts may be transferred to a similar Trust or Society having similar objective or objectives, with the consent of 2/3rd majority in a meeting of the Board of Trustees.

7A(iii) The Trust may acquire or anuigummalet any other Society or Trust having similar objective or objectives with the consent of 2/3rd majority in a meeting of the Board of Trustees.

7A(iv) The Trust may open its Branch office any where in India to achive the objectives more effectively with the consent of 2/3rd majority in a meeting of the Board of Trustees.
